Ι,	_, understand that in order to have an electronic device while
residing at Grace House, I will agree to each of	the following:
I will disclose any and all electronic device	es in my possession while I am a resident of Grace House.
Electronics include but are not limited to iPods,	tablets, laptops, and cell phones.
I will give the Youth Department staff and	my house parents any electronic device that is given to me as a
gift and that is not listed on this contract. I will	ensure to update staff of all electronics.
I will not have any inappropriate pictures of	or videos on my electronic device. This includes sending or
receiving pictures/videos containing nudity, par	tial nudity, violence, unlawful activity, or pictures/videos taken
for malicious purposes (bullying, prank calling,	etc.).
I will not have any inappropriate music on	my electronic device. This includes explicit music with curse
words or any language pertaining to sex, drugs,	or violence.
I will not search any websites containing v	iolence, sex, or any type of pornographic images.
I will not search or sign up for any dating v	websites.
I will give the Youth Department Staff and	House Parents access to my password at all times if my device
is password protected. I will also notify them if	my password changes.
I will not chat or communicate with any ur	nknown persons through my electronic device.
I will not give out any private information	about myself, other Grace House residents, or Grace House staff
through social media.	
I will alert my House Parents immediately	if I am being harassed by someone via my electronic device.
I understand that I am responsible for any	costs pertaining to my electronic device, and it is my
responsibility if it is stolen, lost, or broken.	



I understand that the House Parents and Youth Department Staff have the right to search through my	
electronic device at any time.	
I will turn in all of my electronic devices each night to my House Parent at 10pm; this includes weekend	ds. I
understand I can earn an extra hour if I earn all of my points on the behavior chart.	
I understand that upon my electronic device being returned; I have to remain downstairs supervised the	
entire time I have possession on my electronic device (GH2).	
I understand that I am not allowed to take my electronic device to school or use it during study time	
without permission from the Education Coordinator or Youth Director.	
I understand that I may have my electronic device after study time each day at 5:30pm and it must be	
turned in at 9:00pm each night.	
I will sign my electronic device in and out each day documenting the time I received it and the time I	
turned it in.	
I will not share my electronic device with another resident. I understand that I will be held responsible f	or
whatever is found on my device.	
If this contract is broken in any way; I understand the following:	
1 st time: my electronic device will be taken up for 7 days.	
2^{nd} time: my electronic device will be taken up for 14 days plus a meeting with my social worker will occur.	
3 rd time: my electronic device will be taken for 30 days and I will be placed on a 30 day contract	
4 th time: a discharge will be requested	
Having an electronic device is a privilege and not a requirement or necessity. In order to maintain an electron	nic
device, I must comply with all of the above statements. If I do not, I understand that my House Parents and	
Youth Department Staff have the right to obtain my electronic device until further notice.
